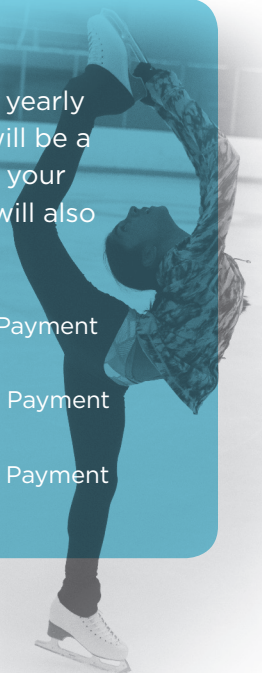
### SILVER PATRON MEMBERSHIP PARTNER

Through this option, the Jones Center will provide a discounted yearly rate of 10% off for all employees of your company. This option will be an annual payment based on the size of your company.
